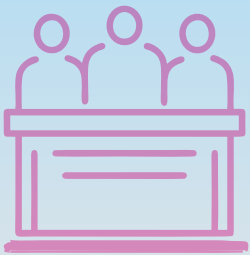
ELIGIBILITY

- Any Indian corporate of any size is eligible to enter.



JURY / SEARCH COMMITTEE

- A panel of jury will judge entries on the benchmarks listed in the 'parameters' section.
- Your organisation will be invited (if required) to present a case study or presentation before the jury/search committee on the project that is nominated for the Award.



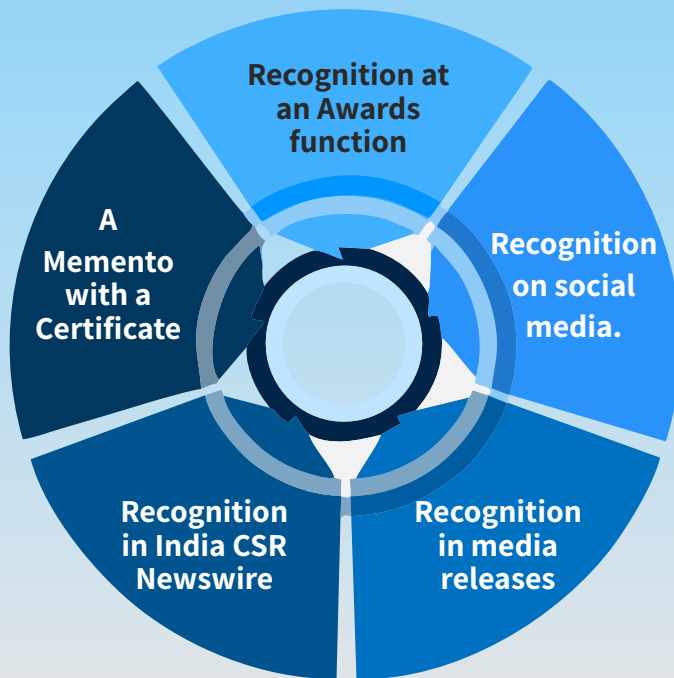
JUDGING PARAMETER

- Entries are judged by a panel of corporate, agency, and academic executives as well as by the staff of India CSR.
- The jury/search committee evaluates entries based on creativity, innovation, sound planning, implementation, and outcomes.

- Corporate: The nomination fee of each entry - ₹ **12,000** - (Including 18% GST)
- Not-for-Profit: The nomination fee of each entry - ₹ **8,000** - (Including 18% GST)
- People - Fee Not Applicable

- The awards process is open to all registered companies in India.
- Data should be furnished for a single entity for the project and not combined with group information.
- The application can be submitted by a company only.
- Nominating a project for an award does not mean winning an honor.
- The jury/search committee will have the exclusive right to accept or reject any application based on its discretion and such decisions will be final.
- The fee is non-refundable and non-adjustable and is only one time payment while submitting the 01-application form.
- There is no separate evaluation fee for different stages of evaluation.
- Companies can apply for one or more Categories of Award.
- Each Award Category would attract a separate fee.
