
The Mission

Report Categories

- For the CSR Report and Sustainability Report categories, you will need to submit a PDF and three hard copies of the report, as well as any additional supporting materials you would like to include.
- A brief summary of the report is also required.



People Category

- The India CSR Awards offer individual recognition for individuals who have made exceptional contributions to the CSR sector through innovation, new knowledge, or improvements to professional practice.
- These contributions should be above and beyond the ordinary and have had a lasting impact on Indian CSR.
- To submit an entry in this category, please provide a brief summary (maximum two pages) of your efforts, including best practices, specific initiatives, and your leadership role.

NGO Category

- NGOs and CSR Implementing Partners are required to submit an outline (no more than 2 pages or 1000 words) along with supporting materials.
- These materials should include testimonials from the organization's funding body, a summary of previously successful CSR programs (outlining campaign objectives and metrics for success), and a description of any unique best practices the agency uses in all its Corporate Responsibility initiatives.

Documentary Category

- To submit for the categories, you will need to provide a YouTube link and a physical pen drive containing the documentary, along with any additional documents or supporting materials you wish to include.
- You should also provide a brief synopsis of the documentary.

Supporting materials should demonstrate the success of your work or intervention. Examples of acceptable supporting materials include: web addresses/URLs, sales figures, media coverage, clippings, photos, research, testimonials, and awards.

Supporting Materials

Supporting materials should demonstrate the success of your work or intervention. Examples of acceptable supporting materials include: web addresses/URLs, sales figures, media coverage, clippings, photos, research, testimonials, and awards.

In the beginning of your 2-page synopsis, please include the following information:

- The category you are entering
- The title of your entry (as it should appear on your award)
- The key contact person for the entry
- The organization submitting the entry
- The budget (if applicable)

Note: all budget information will be kept confidential and will not be published without your expressed permission.

nstructions for Entering the Awards

To enter, please follow these steps:

- Choose the category you wish to enter
- Prepare your entry, including an outline (no more than 2 pages or 1000 words), supporting materials, and a brief synopsis of your work
- Submit your entry via mail to awards@indiacsr.in
- Include the following information in the beginning of your outline: category entered, title of entry, key contact for entry, organization submitting entry, budget (if applicable)
- Ensure that your case study broadly covers the following topics: objectives, research, strategy, execution, evaluation of success, results, impact, and ROI.

ELIGIBILITY



- To be eligible for the award, the CSR initiative must have occurred within the past ten years.
- It is not required for the work to have been completed within this time period, and it can be ongoing.
- Any Indian corporate, agency, association, governmental agency, or non-profit organization of any size is eligible to nominate a project.

Jury / Search Committee

- A panel of judges or search committee members will evaluate entries based on the criteria listed in the "parameters" section.
- Your organization may be invited to present a case study or presentation to the panel or committee on the nominated project for the India CSR Awards.

JUDGING PARAMETERS

Entries are judged by a panel of corporate, agency, and academic executives, as well as by the staff of India CSR. The panel or committee evaluates entries based on factors such as creativity, innovation, sound planning, implementation, and outcomes. The most important criterion is the proven success of aligning strategic objectives with end goals.

The panel or committee will broadly evaluate entries based on the following parameters:

- Objective of the program
- Scope of the CSR project
- Sustainability plan of the project
- Innovative aspects of the initiative
- Implementing method
- Outcomes of the project, including immediate impact and sustainability

- Number and impact of beneficiaries
- Long-term impact of the project
- Documentation and communication
- Overcoming barriers and outcomes
- Project learning and recommendations

Sending the Entry

Full payment must be included with all entries/entry packets. If you are paying by check or demand draft, make a note of the number of entries being paid for. Please ensure that all necessary details are included with your entry.

Requirements for Nominating a Project

To nominate a project for the India CSR Awards, the following materials are required:

- A 1000-word story in Word format detailing the objectives, research, strategy, execution, and evaluation of success/results/SROI for the organization's CSR efforts.
- The story should explain why the organization is a good fit for the chosen award category and should include information about the organization's strategic thinking for CSR, tactics and campaigns deployed, execution, and results (if available).
- The name and contact information (email and phone) of the CSR head for the organization.
- A completed nomination form, which can be downloaded.



The deadline for entries is currently open.

Award winners will be notified and recognized at an awards ceremony.

Submission Requirements

- Include a check with the application materials, which should be provided on a pen drive or other removable storage device.
- All types and sizes of organizations and their units are eligible to participate in the awards.
- The awards process is open to all Indian registered companies, but not to branch offices of foreign entities.

- If necessary, attach additional sheets for more detailed information.
- It is recommended that you nominate innovative CSR projects.
- Data should be provided for a single entity for the project and should not be combined with group information.
- The application may be submitted by a company or the company's CSR foundation.

Confidentiality and Non-Disclosure

- The information provided will be kept confidential and will only be used for the purpose of determining the winners of the awards. The names of applicants, comments, and scoring information developed during the review process are considered proprietary by the awards committee and will be kept confidential.
- This information will only be available to those individuals directly involved in the assessment and administrative process.
- The India CSR will take reasonable steps to ensure that applications and the information contained within them are treated confidentially.
- However, the awards committee cannot be held responsible for any loss of confidentiality or any damages (including to goods, persons, or financial losses) incurred as a result of a breach of confidentiality by the applicants or any disclosing party.
- "Confidential Information" refers to all information provided by the disclosing party (companies applying for awards)

- regarding their products and projects, regardless of whether it is written, oral, recorded on audio or video tapes, computer discs, machines, prototypes, designs, specifications, articles of manufacture, drawings, or other human or machine-readable documents.
- It also includes all information related to photos, drawings, explanations, or examples of information, ideas, concepts, prototypes, designs, patentable or non-patentable inventions or designs, trade secrets, advertising, packaging, documents, programs, plans, specifications, techniques, financial data, financial or production forecasts, patentable or non-patentable inventions, sketches, research, marketing, trade secrets, engineering data, production techniques, schematics, packaging, advertising, and programs, as well as specific information related to the design, development, manufacturing, marketing, selling, and distribution of frequency control products and related goods and services.

The Selection Process



The selection process for the India CSR Awards includes the following steps:

- Assessment of questionnaire responses, including compliance assessment where applicable, based on the information provided by participating companies.
- Selection of nominated companies for assessment by the jury/search committee.
- Field visit/presentation or meeting with the CSR board may also be conducted.
- Final selection of innovative CSR projects for recognition from among the nominated companies by the jury/search committee.



Tips for a Successful Application

To ensure that your application is successful:

- Give yourself enough time to complete the application materials and submit them on time.
- Write clearly and concisely, avoiding jargon and staying within the specified word limits.
- Use evidence, statistics, and results to support your story.
- Explain how your project fits into your company's overall CSR strategy.
- Proofread carefully to avoid mistakes.
- Do not assume that the judging panel is already familiar with your business or CSR projects. Make sure to clearly demonstrate the uniqueness of your project.
