Recognizing impactful initiatives that uplift and develop communities.



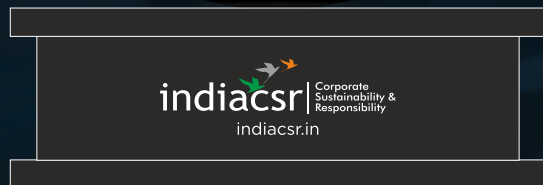
## Innovation in CSR
